# Transparency notifications by BlackRock, Inc.

In accordance with article 14, § 1 of the law of 2 May 2007 on the disclosure of major holdings, Umicore was recently notified:

• By BlackRock, Inc. that it has successively crossed the legal threshold of 3% for the direct voting rights, upwards on 2 December 2024, and then downwards on 3 December 2024.

The total holding of direct voting rights and equivalent financial instruments of BlackRock, Inc. now stands at 3.35%.
