

Transparency notifications by BlackRock, Inc.

In accordance with article 14, § 1 of the law of 2 May 2007 on the disclosure of major holdings, Umicore was recently notified by BlackRock, Inc. that it has successively crossed the legal threshold of 3% for the direct voting rights upwards on 20 June 2025 and then downwards on June 23 2025.

The total holding of direct voting rights and equivalent financial instruments of BlackRock, Inc. stands at 4.26% on 23 June 2025.
